# The Accreditation Pathway and Continuing Professional Development

Strata Community Association (Qld) is raising the bar for body corporate manager and supplier accreditation as well as ongoing education.

The 2021 accreditation pathway is now aligned with other Australian jurisdictions that have licensing or regulation in place and will provide a nationwide benchmark for body corporate manager qualification and professional development. The accreditation levels are designed as a pathway, building onto each level accumulating credentials.

#### Why Accreditation?

SCA (Qld) values high quality education, a solid career pathway for body corporate managers and a universal set of credentials for consumers to understand the qualifications of accredited managers. Strong professional development requirements lift the bar of the sector's professionalism. Accreditation:

- · builds a profile for the sector
- fosters professionalism
- creates consumer confidence in the capabilities of professionals
- is a tool to market your professional credentials
- builds your career.

On 1 July 2021 eligibility criteria for SCA (Qld) membership will change to align with the National Accreditation Pathway.

### **How can I obtain CPD Points?**

Category 1	2021/22 CPD Policy
Non SCA delivered training (other than through an RTO)	1 point per 3 hours of training (no less than 0.25pts)
Non SCA delivered training by a pre-approved SCA Training Provider (CPD One-on-One)	1 point per 1 hour of training (no less than 0.25pts)
SCA (Qld) delivered training	1 point per 1 hour (includes up to 1 hour)
SCA (Qld) Conference / Symposium / Leadership Forum	Max. 4 points per event
SCA Annual Conference	Max. 3 points per day

SCA A100 Essential of Strata Community Management	Max. 6 points (3 days or full online course)
Certificate IV or Diploma qualification in Strata Community Management	3 points per completed individual module, max. 12 points per annum
